

Notice of Rate Increase
Proceeding No. 24AL-0121TR

Wild Side 4 x 4 Tours, LLC filed Passenger Tariff, Colorado PUC No. 3 with the Colorado Public Utilities Commission on March 14, 2024. The proposed effective date of the tariff is April 14, 2024.

Wild Side 4 x 4 Tours, LLC under Certificates No. 55983, may provide sightseeing service between all points within a 20-mile radius of the intersection of West Elkhorn Avenue and Moraine Avenue in Estes Park, Colorado.

Wild Side 4 x 4 Tours, LLC in Passenger Tariff, Colorado PUC No. 3 proposes to increase the rates for the sightseeing service authorized by Certificate No. 55983.
